RELEASE AND WAIVER OF LIABILITY AGREEMENT

I AM AWARE THAT THESE ACTIVITIES ARE HAZARDOUS ACTIVITIES AND THAT I COULD BE SERIOUSLY INJURED OR EVEN KILLED. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED AND AGREE TO ASSUME ANY AND ALL RISKS OF BOLIDY INJURY, DEATH OR POPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.
