RULES:

1. **Date & Time** ~ Sunday, May 26th, 10:00 a.m. – 12:00 p.m. (Auditions)
2. **Location** ~ Community Stage
3. **Age** ~ Contestants must be 14 years old and under and accompanied by a parent or guardian.
4. **Admission & Parking** ~ Admission for participants and 1 chaperone will be free. Parking is \$10.00.
5. **Music** ~ No more than 2 minutes on a CD or mp3, unless performing accappela. Contestants should come prepared to perform two songs/acts/dance routines/ etc. Only one act will be performed in the first round, but if the judges are unable to agree on a winner, contestants may be asked to perform an additional act. This has never happened before but please be prepared.
6. **Judges** ~ All contestants will be judged according to the following criteria: Appearance, Composure, Talent and Overall Performance.
7. **Finalists** ~ 10 to 12 finalist will be chosen to move on to the Kids' Talent Finals later on the same day at 1:30pm. Finalist will be notified by phone within 30 minutes after the Auditions.
8. **Awards** ~ All contestants will receive a participation ribbon.
 - a. Winner will receive \$150, and additional gifts.
 - b. 2nd Runner Up will receive \$75, and additional gifts.
 - c. 3rd Runner Up will receive \$50, and additional gifts.
